The week will consist of General Sessions, NOBP Region meetings, Council Meetings, educational classes and setting the NOBP Policy. Please plan departure flights no earlier than 6:00 p.m. on Thursday, August 7.

Councils that request additional meeting time have the option to meet on Thursday, August 7, after the NOBP Policy is set.

Hotel Information

A block of sleeping rooms is reserved at the Westin Hotel, 1000 Penn Ave., Pittsburgh, PA 15222.
